I was reading the other day about our COLA raise this year being zero for Veterans and Social Security. The government employees, however, are getting a very small increase and their union is complaining saying they are over-worked. This is about the most untrue statement I have ever heard about the government employee being OVER-WORKED, in my opinion. It used to be you went to work for the government for the benefits, not the salary. Now they get both benefits and salaries, do little work and still complain! I have never been a fan of the unions since high school but I'm wondering if they may help the veterans and the active duty get a fair share! It was just a thought that ran through my brain for an instance.

Speaking of government workers, the Attorney General of the U.S. decided not to press charges to two VA senior executives [one with \$400,000 worth of relocation expenses] for her promotion and defrauding the VA. They get to keep their job and go through a dismissal process that will not happen because of the union. Once again, crime and such being swept under the rug and Veterans can't get a claim through in reasonable time or a fair hearing. Perhaps the VA employees should spend a couple of weeks on a forward outpost in Afghanistan or wherever we go next before they can evaluate a VA claim! Last year, the VA was found to have over a billion dollars of wasteful spending, according to Senator McClain. Wouldn't that help a lot of veterans who need their fair share in a timely manner!! As the saying goes, the Veteran and Jesus Christ are the only ones who have given up their lives for us [Jesus] and the soldiers who signed a blank check up to and including their lives when they swore their oath to "defend the country against all enemies foreign and DOMESTIC"!

The cost for this for a year is \$129.00 for you and spouse. I rarely advertise for anybody in this column, but this is important as I have it, and almost had to use it from a fall I had on a cruise ship. Veterans' courts are hybrid drug and mental health courts that use the drug court model to serve veterans struggling with addiction, serious mental illness and/or co-occurring disorders. They promote sobriety, recovery and stability through a coordinated response that involves cooperation and collaboration with the traditional partners found in drug and mental health courts in addition of the U.S. Department of Veterans Affairs health care networks, the Veterans' Benefits Administration, and, in some programs, volunteer veteran mentors and veterans' family support organizations.

GAME FIX?

Some computer games may not be compatible with Windows 10, and as a result they will download and install, however when you click to open the game, nothing happens.

You can try to resolve the problem and allow the games to open by:

- •Right-clicking on the game icon from the desktop and choose 'Properties'.
- Select the 'Compatibility' tab.
- •Check 'Run this program in compatibility mode for: 'Windows XP (Service Pack 3)'.

Also try choosing the 'Windows 7' option if Windows XP does not work.

- •Make sure you check the box "run this as an administrator"
- •Click 'Apply' and then OK.
